

**NoMa in Color Sweepstakes  
(THE "SWEEPSTAKES")  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.**

**1. Sweepstakes Period:**

The Sweepstakes begins on September 9, 2023, at 11:00 a.m. Eastern Time ("ET") and ends on October 19, 2023, at 7:00 p.m. ET (the "Sweepstakes Period").

**2. Eligibility:**

Open to residents of all U.S. states (excluding Hawaii and Alaska), Puerto Rico, and the District of Columbia, who are twenty-one (21) years of age or older at the time of entry. Persons in any of the following categories are NOT eligible to participate or win a prize: (a) any person who, at any time on or after September 9, 2023, was or is a director, officer, agent, representative, or employee of the NoMa Business Improvement District ("Sponsor"), or its parent, affiliates, subsidiaries, or service agencies, who is directly involved in the planning or execution of the Sweepstakes; (b) any other individuals engaged in the development, production or distribution of materials for the Sweepstakes or engaged in the administration or execution of this Sweepstakes; (c) persons who are or purport to be immediate family members (defined as biological or step-mother/ father, sister, brother, daughter, son, dependent or spouse of any of the foregoing) of any person in any of the preceding categories, regardless of where they live, or who reside in the same household as any person in any of the preceding categories; and (d) persons who Sponsor is prohibited from allowing to participate in the Program under applicable law. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. VOID WHERE PROHIBITED BY LAW.

**3. How to Enter. NO PURCHASE NECESSARY:**

Failure to follow all instructions in these Official Rules may lead to disqualification. Enter by: (1) downloading the official NoMa in Color passport at [www.nomabid.org](http://www.nomabid.org) OR picking up a paper official NoMa in Color passport from the NoMa BID Welcome Tent (see below for locations/times) (2) checking in to all locations indicated on the passport by 7 p.m. ET on October 19, 2023; (3) if using a paper passport, submitting the fully completed passport to the NoMa BID Welcome Tent by 7 p.m. ET on October 19, 2023. Paper passports will be available to be picked up in person at the NoMa BID Welcome Tent at the NoMa in Color Kickoff Party at Alethia Tanner Park on Saturday, September 9 from 11 a.m. - 3 p.m. and on Thursday evenings from 5:00 - 7:00 p.m. between September 14 – October 19, 2023, at the NoMa BID Welcome Tent (1200 1<sup>st</sup> Street NE). Entries made through the internet are deemed to be made by the authorized account holder of the email address at the time of entry. Entries will not be returned or acknowledged. Entrants must fully complete and timely submit all required data online or on paper passports, as applicable, to be eligible (an "eligible entry"). Sponsors' administrator's server/computer is the official time keeping device for the Sweepstakes. By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects.

**4. Selection of Winners and Odds of Winning:**

On October 31, 2023, Sponsor will randomly draw five (5) entries for the Sweepstakes Prize from among all eligible entries received ("Potential Winner" and, if verified, "Winner"). The odds of winning a prize depend on the total number of eligible entries received during the Sweepstakes Period. Potential Winner will be subject to verification of eligibility and compliance with these Official Rules.

**5. Prizes**

Each Winner will receive a \$100 gift card to a NoMa-based business (the "Prize"). The total approximate retail value of all prizes awarded under this Sweepstakes is: \$500. Only one prize per person and per household will be awarded. Prizes may not be assigned, transferred, exchanged, or redeemed for cash. Each Prize is awarded "AS IS" and WITHOUT WARRANTY OF ANY KIND, express or implied. Sponsor disclaims all and any liability for the actual provision, quality or nature of any third-party product or service accepted by the Winners. Entrants understand that Sponsor is not liable for injuries, losses or damages of any kind arising from participation in this promotion and acceptance, possession and use of a Prize. Any portion of the Prize not used will be forfeited. Winner is responsible for all taxes and fees associated

with a Prize receipt and/or use. Sponsor is not responsible for any typographical or other error in the printing of the offer, administration of the Sweepstakes, or in the announcement of the prizes.

## 6. How to Claim Prize

Potential Winners will be notified by email by 11:59 p.m. ET on October 31, 2023. Winners must reply to email from NoMa BID to confirm acceptance. NoMa BID will confirm if prize can be emailed or picked up in person by the Winner from the NoMa BID offices located at 1200 First Street NE, Suite 310, Washington, DC 20002 within 10 business days of the date of the email notification. Failure to confirm and/or pick up Prize will result in forfeiture and at the Sponsor's sole discretion, the Prize may be awarded to an alternate Potential Winner.

If a Potential Winner cannot be contacted, fails to timely claim the Prize, is found to be ineligible or not in compliance with these Official Rules, fails to timely execute and return any required forms, or if the Prize notification is returned as undeliverable, the Prize will be forfeited and, at the Sponsor's sole discretion, the Prize may be awarded to an alternate Potential Winner selected in a random drawing from the remaining valid entries. Potential Winner must provide proof via a valid government issued photo ID for age and residence verification. Sponsor may select up to three (3) alternate Potential Winners via random drawing from among the remaining eligible entries; thereafter, if a Potential Winner cannot be verified in accordance with these Official Rules, the Prize will not be awarded. The Potential Winner must execute and return any required affidavit of eligibility and/or liability/publicity release or such Potential Winner forfeits the Prize.]
